#### ANNUAL MEETING

The Annual Meeting of the Memorial Society of RI will be held at 3 PM on Sunday, June 7 in the fellowship hall of the Westminster Unitarian Church, 119 Kenyon Ave., East Greenwich, to hear reports from the President and Treasurer, to elect three Directors to serve until 1984, and to make amendments to the bylaws of the Society (text of changes on page 2).

A program for members and other interested people will precede the business meeting. It will feature a discussion of "living wills" by Rep. Anthony Carcieri, who recently presented a bill on the subject in the State legislature, and who will speak on the legal aspects, and John Ladd, Professor Philosophy at Brown University, who will discuss some of the theoretical and philosophical concepts involved.

#### WIDE INTEREST SHOWN IN MEMORIAL SOCIETY

A question sent to the Providence Journal-Bulletin's "Action Line" in January sparked an interview with Memorial Society President Fred Gillis. The reply in the paper listed the Society as a source of information on alternative funeral arrangements. This produced over 50 inquiries and several memberships. Subsequent TV appearances have resulted in several more inquiries.

#### MEMORIAL SOCIETY INCORPORATED

The Memorial Society of Rhode Island is now officially incorporated under R.I. law as a "non-business'corporation". It is also registered with the federal Internal Revenue Service as a tax exempt organization. Membership in the Continental Association of Funeral and Memorial Societies is now pending approval of bylaw changes.

The Society offers to members basic information on relevant laws and available funeral services and has set up a recording keeping service for members who wish to have their funeral plans on file in a place outside their home.

The Memorial Society of R.I. now has 17 individual memberships and 29 family memberships. This represents about 76 people. Over 120 have shown interest in the services of the Society. Spread the word to your friends. The more members we have, the stronger is our voice.

One of the necessary headaches which every organization must deal with is the legal aspects. We thought we had the details of our bylaws straightened out last June, but when we applied for membership in the Continental Assoc. of Funeral and Memorial Societies, we were informed that there were a couple of flaws that had to be corrected if they would accept us.

Since there are some so-called "memorial societies" which are not non-profit and controlled by their members, but are actually pre-paid, money making funeral businesses, we must make it clear that the societies with which we offer reciprocal membership and information exchanges are truly non-profit and democratically controlled, and preferably members of CAFMS or the equivalent Memorial Societies Assoc. of Canada.

It is generally accepted according to parliamentary procedure that bylaws may be changed only by a 2/3 vote, not just a majority as our present bylaws state. In addition, there should be provision for the membership at large to call a general meeting.

Changes have been made by the Board and these have been approved by the CAFMS. See the text of the changes below.

BYLAW CHANGES PROPOSED FOR ANNUAL MEETING

The following changes in our Bylaws are proposed for the Annual Meeting on June 7. Additions are underlined.

## Article III, Section 7

The society will provide the same service, advice, and assistance that it offer to its own members to members of other memorial societies that belong to the Continental Association of Funeral and Memorial Societies or the Memorial Society Association of Canada, and to members of those independent memorial societies that are clearly non-profit and democratically controlled.

#### Article IV, Section 2

A member of another non-profit, democratically controlled memorial society (see Art. III, Sect. 7) moving into the Rhode Island area will be welcomed as a member in good standing..

#### Article V, Section 1

Meetings will be called by the Board of Directors, or by a petition signed by any 7 members of the society, on 10 days notice, which notice shall state the business to be transacted.

#### Article VII

These By-laws may be amended by vote of 2/3 of the members present..etc.

# RULES FOR CREMATIONS FOR ROMAN CATHOLICS

We have had several inquiries from Roman Catholics who wish to be cremated and do not know what the Church permits. Before the 2nd. Vatical Council cremation was not acceptable for Catholics. It is now permitted under certain conditions. A directive from Bishop Gelineau's office reads as follows:

"Permission for cremation may be granted by the Ordinary in individual cases. In these instances the burial of cremated remains should take place in a Catholic cemetery and arrangements for the burial of the cremated remains should be made by the funeral director with the Diocesan Cemetery Office at the time this permission is granted."

Those wishing cremation should put their request in writing and send it to the Bishop's office. It should be understood that there must be a regular funeral service in the church with the casker present before the cremation takes place. Scattering of ashes is not permitted. Those with further questions should communicate with the Bishop's office.

#### ADE BETHUNE FEATURED

Memorial Soc. member and former President Ade Bethune was featured in an article in the Providence Journal in which she explained her belief in simplicity in funeral practices and talked about the coffin (not casket!) she has already built. Plans for a momemade coffin can be obtained from Miss Bethune for \$2.50 by writing St. Leo's Society, Box 744, Newport, RI 02840. She uses hers as a blanket chest!

#### TELL YOUR FRIENDS

Memorial Societies are essentially consumer organizations. Their strength depends on numbers. If you have friends whom you know believe in simplicity in funeral arrangements, tell them about the Memorial Society. The Memorial Society of British Columbia in Canada began with a small group about 20 years ago. It now has over 150,000 members! The word gets around: There are many people who want simplicity and not the conventional funeral.
