FUTURE OF THE MEMORIAL SOCIETY OF RHODE ISLAND

Comment by Polly Barnett-Birdsall, President

Now that the Funeral Practices Rule is a reality, is the work of memorial societies over? People who should know better (like me) have been wondering out loud if memorial societies have outlived their usefulness, now that the long-awaited FTC rule has been in effect for two years. What made me change my opinion about the need for memorial societies was a growing awareness that Rhode Island funeral directors are not complying with the Rule in some instances. That means that the Rule isn't working as it should. The FTC is depending on memorial societies to provide monitoring and to furnish them with data on compliance or non-compliance. So the job falls to us.

The MSRI performs two separate but connected functions: one political and the other educational. Politically we have been active, through our lobbyist and board vice-president Bill Grande, in pushing for the passage of Living Will or Durable Power of Attorney legislation in Rhode Island. We have been active as well in monitoring compliance with the Funeral Practices Rule. Board members and members at large have worked hard at gathering data on compliance by the state's funeral directors with the FTC Rule. That effort included an extensive telephone effort by several MSRI members to Rhode Island funeral directors to ask them to furnish prices for goods and services over the telephone as required by law. A report on the results of that survey appears elsewhere in this newsletter.

So, is the MSRI out of business? No, it's not. Our watchdog function is critical to determine compliance (or lack of it) with the Funeral Practices Rule. Our educational function will continue as long as persons need information and encouragement to plan their funerals in advance of need.



FTC RULE SURVEY

A survey of Rhode Island funeral homes was conducted by members of the Memorial Society of Rhode Island this spring to determine whether the state's funeral establishments are complying with the Funeral Practices Rule. The Rule requires that funeral directors disclose itemized prices for goods and services over the telephone.

Complete results of the survey effort are not yet tabulated, but those received thus far indicate that the majority of functe! directors in the state are complying with the Rule. Some are in the "partial compliance" category, and a few are flatly noncompliant, that is, they did not furnish itemized prices for goods and services when asked to do so over the telephone.

Members participating in the survey telephoned funeral homes and asked for price breakdowns for such items as embalming and cosmetology, use of hearse and other vehicles, staff and support services, and transportation costs. They were also asked about direct burial and direct cremation costs.

Complete results of the survey should be available in time for our Annual Meeting.
